





### NOTEWORTHY ACCOMPLISHMENTS

- Central Plant structural concrete work continues on schedule. Formed base slabs B1B and B2B, and formed upper deck for contactors at TPS. Started groundwater dewatering for Filter Module 2.
- EWP4 completed shoring installation at 142.50 Jack's Ditch. Initiated excavation for Tunnel 2.0. Welding and grouting of joints is ongoing.
- EWP6 North Plant structural concrete work for stem walls, cross collectors, and base slabs is ongoing.
- EWP 6 IPS set casing templates for 120" pump can casings. Completed formwork for IPS platform structure and completed flow fill installation for structure piles.
- South Plant initiated installation of stone columns for GST 1 and 2, and completed formwork and rebar for OF structure. Completed site prep work for switchgear building.

- Complete EWP4 crossing of 66 water line at STA 128+50

- Continue excavation for east filter complex and liquid residual equalization and begin structural work *December*
- Continue control narrative coordination workshops December/ January/February
- Begin duct bank installation in new facility December
- Begin medium voltage underground for Main Switchgear Building (Bldg 111) – *January*
- Begin decking at the Influent Pump Station December
- Begin 66" raw water realignment on north side of property – December/January
- Begin concrete work at Post Treatment Chemical Facility (Bldg 311) *January*
- Begin bypass drain pump can installation in Central Plant east – January
- Begin install of 84" and 96" FW pipeline in Corridor 4 to HSPS – January/February
- Begin install 108", 84" and 120" FW pipelines in Corridor 5 – January/February
- Begin mass excavation of the Gravity Sludge Thickener Complex 501 and 502 *January*
